



## BRIDAL SERVICE CONTRACT

This Service Contract is made effective as of \_\_\_\_\_ (date), by and between \_\_\_\_\_ (name) and wedding party ("Client(s)"), and Primped LLC ("Primped") of Minnesota.

**DESCRIPTION OF SERVICES.** On the date of \_\_\_\_\_, Primped will provide onsite hair and makeup services as described in the attached invoice (collectively, the "Services").

**PAYMENT.** Payment shall be made to Primped LLC. \_\_\_\_\_ (name) agrees to pay Primped as follows:

The \$150 initial deposit, to be paid by \_\_\_\_\_ (date), is non-refundable. This will secure the date of service and will be applied as a credit to the final invoice toward the bride's services. The remaining amount due must be received in full no later than 14 days prior to the scheduled event.

Any other fees (such as parking reimbursement to the stylist, or for additional services added the day of the event) will be due immediately on the day the service is provided.

**GUARANTEE.** Primped shall provide its services and meet its obligations under this Contract in a timely manner, and will provide a standard of care equal to, or superior to, care used by service providers similar to Primped.

**DELAYS:** In the event scheduled services exceed the allotted time due to client delays, the artist will make every effort to accommodate the bridal party. Primped has full discretion, based on availability, whether or not to continue services past the scheduled end time. Incompletion of services based on a client delay does not warranty a refund or discount on the final total due.

**CANCELLATION/AMENDMENT POLICY:** Client(s) may add services up until the day of the event, subject to artist availability. The Client(s) will make every attempt to provide advance notice of

any cancellations. The final payment is due 14 days prior to the event and is non-refundable. Any cancellation request received after that date will not result in a refund.

**LIABILITY:** All brushes and makeup products are properly sanitized between every makeup application. Any skin condition should be reported by the client to the artist prior to application and, if need be, a sample test of makeup may be performed on the skin to test reaction. By signing the contract, Client(s) agree to release the artist from liability for any skin complications due to allergic reactions.

**FORCE MAJEURE.** If performance of this Contract or any obligation under this Contract is prevented, restricted, or interfered with by causes beyond either party's reasonable control ("Force Majeure"), and if the party unable to carry out its obligations gives the other party prompt notice of such event, then the obligations of the party invoking this provision shall be suspended to the extent necessary by such event. The term Force Majeure shall include, without limitation, acts of God, fire, explosion, vandalism, storm or other similar occurrence, orders or acts of military or civil authority, or by national emergencies, insurrections, riots, or wars. The excused party shall use reasonable efforts under the circumstances to avoid or remove such causes of non-performance and shall proceed to perform with reasonable dispatch whenever such causes are removed or ceased.
